Who is the course intended to help.

Aims:

The course aims to provide those with the responsibility for the day-to- day supervision of others with an understanding of their legal duties, the fiscal and moral case for effectively managing the health and safety arrangements within the company.

	 Recognise the need to pass on any suggestions for reducing risks to health and safety to the responsible person(s)
	 Demonstrate that their personal conduct in the working environment does not endanger the health and safety of themselves or other persons
	 Review the instructions for the safe use of equipment, materials and products
	 Report any differences between responsible persons instructions and suppliers or manufacturer's instructions as appropriate
	 Report those hazards which present the highest risk immediately to the person(s) responsible for health and safety in the working environment
	Demonstrate working practices in accordance with work place instructions and legal requirements
	 Demonstrate how to follow environmentally friendly working practices
	• Demonstrate personal behaviour in the working environment that protects the health and safety of them- selves and others, and is in accordance with instructions

Outline of Unit Content

This course is aimed at anyone who is responsible for supervising workers in a working environment.

It deals with the knowledge required to make sure that:

- Workers are inducted into the workplace; adequately supervised; and made aware of their responsibilities in relation to health and safety;
- Supervisors can identify significant risks in the workplace, and
- Take appropriate action to put things right, including: reporting, dealing with situations which pose a danger to themselves and others in the workplace and seeking advice where necessary.

The aim is for them to demonstrate knowledge of significant health and safety risks in a working environment and being able to identify and deal with them appropriately to ensure workers are not exposed to undue risk.

Outline of Proposed Learning Activities/Approach to Delivery

The programme is delivered on line and is available 24/7 from anywhere that has an internet connection.
